**CONSUMPTION OF ALCOHOL IN PUBLIC PLACES  
WESTCLIFF PRECINCT**

**1. OBJECT AND KEY POINTS IN THIS REPORT**

- 1.1 To propose taking the final steps in making an Order designating the area comprising Westcliff Precinct and the area inside the boundary in Appendix 1 restrictions are placed on the public consumption of alcohol.

**2. BACKGROUND INFORMATION**

- 2.1 As authorised by Council at its meeting on 20 January, 2010 and in accordance with statutory procedures consultation has been undertaken with the Police and Licensees and owners or occupiers of any premises or land in the area which might be affected. Public notice has also been given in the local press of the proposed designation.
- 2.2 There have been no adverse representations within the period allowed.

**3. ISSUES TO BE CONSIDERED**

- 3.1 It is now open to the Council to follow the remaining procedure to bring the Order into effect.
- 3.2 This necessitates making the Order, giving public notice that it has been made and erecting appropriate signs in the designated area.
- 3.3 A copy of the Order has to be forwarded to the Secretary of State for information.
- 3.4 It is proposed that the Order takes effect on 17 March 2010 or as soon as possible thereafter.
