#### **CONSULTANCY USAGE: QUARTER 1 2013/2014**

#### 1. OBJECT AND KEY POINTS IN THIS REPORT

- 1.1 Cabinet has introduced a protocol for the use of consultants as part of a package of cost management measures.
- 1.2 The protocol requires services to report their use of consultants on a quarterly basis. This reporting requirement was formally adopted as part of the council's updated contract procedure rules in May 2012.
- 1.3 This report for Quarter 1 2013/2014 has been produced by the council's procurement team in conjunction with directorates.
  - The council spent £139,159 on consultancy services in Quarter 1 of 2013/2014. This represents a £4,782 increase in expenditure compared to the same period in 2012/13
  - Consultancy to support major projects BSF (c. £80m programme) and Waste (c. £200m project) accounted for c .27% of spend in Quarter 1. Other construction and technical related expenditure accounted for c. 32%
  - Overall services have reported that their use of consultants overall has been effective

#### 2. BACKGROUND INFORMATION

- 2.1 The protocol for managing consultancy was introduced as part of a package of cost management measures in 2011. The protocol requires services to report their use of consultants on a quarterly basis. This reporting requirement was formally adopted as part of the council's updated contract procedure rules in May 2012.
- 2.2 Following the introduction of the protocol, the council benefited from a significant reduction in consultancy spend in the region of c. £708,288 in 2012/13.
- 2.3 This report sets out a summary of consultancy usage for Quarter 1 in 2013/2014. During Quarter 1 the council spent £139,159 on consultancy services. Detailed findings are presented at Appendix A.
- 2.4 This report also details projected consultancy spend for Quarter 2 as provided by directorates.
- 2.5 The council spent £38,043 on consultancy to support major projects in Quarter 1, which accounted for c.27%. This represents a reduction of £26k compared to the same period in 2012/13. The BSF programme is valued at c. £80m and the Waste project at c. £200m. The importance of obtaining high quality legal,

- financial and technical advice for complex high value projects with a lifespan in the region of 25 years is axiomatic.
- 2.6 The tables below detail Quarter 1 expenditure compared to the same period in the previous financial year. In addition they set out a projected spend for Quarter 2 2013/14.

2.7 Whilst there is no universally accepted definition of consultant, services have used the following guidance in preparing their returns:

"A consultant is a person (not an employee), agency or firm engaged for a limited period of time on a fee basis to carry out a specific task or tasks. A consultant provides subject matter expertise and/or experience to the Council either because it does not possess the skills or resources in-house or because an independent evaluation is required. A consultant does not include agency staff/interim employed to cover vacancies or peaks in workload etc".

- 2.8 Services engaging consultants reported that overall they have been satisfied with performance and effectiveness. Details are set out in Appendix A.
- 2.9 A number of the consultant engagements relate to the provision of specialist technical services, specifically structural engineering design related services in support of construction projects in progress at a range of council facilities. These account for £16,140.51 in Quarter 1. The council currently does not employ any in house structural engineers and therefore expert external support is engaged. However, the Places Directorate is currently in the process of seeking to recruit to two posts. If successful, this will reduce future external spending in this area.
