**Integrated Assessment Progress**

**1. OBJECT AND KEY POINTS IN THIS REPORT**

- 1.1 To report on progress against actions agreed at the Health and Wellbeing Board on 8 December 2017.

**2. BACKGROUND INFORMATION**

- 2.1 The North Lincolnshire Integrated Assessment, (previously known as the Joint Strategic Assessment) is the evidence base which supports our local Joint Health and Wellbeing Strategy. The Assessment is available on the link below. It will be used by partner agencies to inform the refresh of the Joint Health and Wellbeing Strategy and place based commissioning plans.

- 2.2 The Integrated Assessment incorporates North Lincolnshire's statutory Joint Strategic Needs Assessment and Pharmaceutical Needs Assessment, (which focus respectively on health and social care, and pharmaceutical service needs), and presents a high level summary of other themed place based assessments, including the Joint Strategic Intelligence Assessment, (which focuses on community safety priorities), the Economic Assessment, the Local Account, Market Position Statement, as well as North Lincolnshire's Local Development Framework.
- 2.3 At the Health and Wellbeing Board meeting on 8 December 2017, the Board considered the options for developing the Integrated Assessment. These options were based on the proposed outcomes of the 'Building on Success' consultation workshop held on 8<sup>th</sup> September 2017, hosted by the Health and Wellbeing Board.
- 2.4 The Board resolved :
- (a) that the Integrated Assessment be refreshed and aligned to the four strategic outcomes of 'safe', 'prosperous', 'well', and 'connected'.

(b) that the Board receive an update on the Staying Well refresh at its meeting on March 16 2018, along with the timetable for the revisions required for the other key areas of the Integrated Assessment.

(c) that an outline plan for asset mapping and community consultation be presented to the 16 March 2018 meeting, for completion later in 2018.

(d) that the Board request the task and finish group identify lead officers for each outcome area ensure that this work is completed.

This reports provides the Board with a progress report against these actions

### **3. PROGRESS AGAINST AGREED ACTIONS**

#### **3.1 The board resolved that the Integrated Assessment be refreshed and aligned to the four strategic outcomes of 'safe', 'prosperous', 'well', and 'connected'.**

- The North Lincolnshire Executive Director, Head of Paid Service, has requested an initial Integrated Assessment report to support the development of the Place plan and the Council plan. This initial Integrated Assessment Framework will be complete by March 20<sup>th</sup> with a published document completed by the end of April 2018. The Integrated Assessment Group has met three times since December to plan and develop this work and a briefing has been provided for the Heads of Service.
- The report will be structured so that the content is under the four strategic outcomes of 'safe', 'prosperous', 'well', and 'connected'.
- The Integrated Assessment will provide a high level summary providing a narrative of the key needs and assets in North Lincolnshire. This will include headline strengths and areas for improvement/challenges, key facts and figures, data gaps, priority areas for development based on data analysis.
- The Integrated Assessment will also link with more detailed datasets and reports.

#### **3.2 The board resolved that the Board receive an update on the Staying Well refresh at its meeting on March 16 2018, along with the timetable for the revisions required for the other key areas of the Integrated Assessment.**

- Work has progressed on refreshing the evidence base behind the Staying Well section of the Integrated Assessment. This will be completed and presented to the next meeting of this Board. Thereafter it will be available online, with access to data at ward, locality and care network level being available on the Council's Data Observatory.
- After the completion of the initial Integrated Assessment framework previously described. Members of the Integrated Assessment task group

have agreed to revise and update all sections of the Integrated Assessment.

- Whilst there is no national requirement to maintain an integrated strategic assessment, health and social care commissioners are required to demonstrate that their plans are based on up to date assessments of local population need. There is also an expectation within national inspection frameworks, that local authority and Clinical Commissioning Groups will provide evidence of local integrated system-wide, place based intelligence. It is expected that this refresh will be achieved by September 2018.

**3.3 The board resolved that an outline plan for asset mapping and community consultation be presented to the 16 March 2018 meeting, for completion later in 2018.**

- Public Health England (PHE) are developing a 'Health Asset Profile' at local authority level, with 65 suggested indicators, with more data and indicators to be added later. This will enable us to benchmark ourselves against other parts of the country. Work is in progress to develop these profiles, and North Lincolnshire Council staff are working closely with PHE to share best practice on categorising and mapping health assets.
- Assets will be identified in the Integrated Assessment report using routinely collected data on physical and social assets, as well as data from recent consultations and user voice groups, including the voice of young people and vulnerable groups.
- North Lincolnshire Council Transformation Plan includes Public Engagement provisions. It aims to increase public confidence, participation and changing the way we enable and empower residents. Key actions include:
  - Interaction with the public: decision making, information, current updates, being available, someone to listen.
  - Empower – what can communities do for themselves, create stronger more resilient communities
- More detailed plans will be produced to engage communities in local asset mapping by September 2018.

**3.4 The board resolved that the Board request the task and finish group to identify lead officers for each outcome area to ensure that this work is completed.**

- This action has been achieved, with lead officers in the multi-agency task group now identified to lead the four strategic outcome areas within the Integrated Assessment. They are responsible for coordinating and editing each section, as contributions are required from a number of staff and partners to cover the key areas of work.

#### 4. **RESOURCE IMPLICATIONS (FINANCIAL, STAFFING, PROPERTY, IT)**

4.1 There are no immediate financial or other implications. However, it is intended that future commissioning, planning and delivery of services will be informed by the Integrated Assessment. These are likely to have significant resource implications.

#### 5. **OUTCOMES OF INTEGRATED IMPACT ASSESSMENT (IF APPLICABLE)**

5.1 The content of the Integrated Assessment report will be a key resource for describing the numbers and needs of people with protected characteristics in North Lincolnshire.

#### 6. **OUTCOMES OF CONSULTATION AND CONFLICTS OF INTERESTS DECLARED**

6.1 The Building on Success report was directly informed by the consultation event about the Integrated Assessment. Further consultation and engagement will continue as part of this work, including discussions with the proposed Health and Wellbeing Partnership and those not involved to date.

#### 7 **RECOMMENDATIONS**

7.1 That the board accept the initial Integrated Assessment report to support further development at its summer 2018 meeting. The report will be structured so that the content is under the four strategic outcomes of 'safe', 'prosperous', 'well', and 'connected'.

7.2 A full Integrated Assessment report will be available for the autumn 2018 meeting of the board, which is likely to be subject to consultation and engagement with the proposed Health and Wellbeing Partnership and others. This will include revisions and updates all sections of the Integrated Assessment.

7.3 That the board accept detailed plans for asset mapping and community engagement at the autumn 2018 meeting.
