**PROPOSED DIVERSION OF PUBLIC FOOTPATH 210,
AND PROPOSED STOPPING UP
OF PUBLIC FOOTPATH 210A, MANTON**

1. OBJECT AND KEY POINTS IN THIS REPORT

- 1.1 To determine an application from Sibelco UK, formerly WBB Minerals, temporarily to (1) divert a section of Public Footpath 210 and (2) stop up of Public Footpath 210A Manton.
- 1.2 The key points in this report are:
- a) the section of footpath 210 to be temporarily diverted proceeds in a southerly direction for 540 metres, then in an east-south-easterly direction for 840 metres;
 - b) the section of footpath 210A to be temporarily stopped up proceeds in an east-south-easterly direction for 770 metres;
 - c) the proposed diversion would proceed in an east-south-easterly direction for 730 metres along the inside of the northern perimeter of the site; and
 - d) all three routes adjoin Public Bridleway 241, which runs alongside the eastern perimeter of the site.

2. BACKGROUND INFORMATION

- 2.1 On 6th October 2004 members approved the making of an order under the Town and Country Planning Act 1990 to divert temporarily a length each of Public Footpaths 210 and 210A, Manton, for a period of five years.
- 2.2 The order was necessary for the implementation of Planning Application 1999/169. The Planning Application granted permission for the extraction of silica sand from land at Messingham Quarry, off Kirton Road, Manton.
- 2.3 Public Footpaths 210 and 210A Manton currently cross the land affected. In order for the operation of sand extraction to continue,

therefore, it is necessary that these paths remain closed. A safe alternative footpath has been provided along the northern perimeter of the site.

- 2.4 The report to Planning Committee on 6th October 2004 stated that if towards the expiry of five years it remained necessary for one or both footpaths to remain diverted/closed, a further report was to be resubmitted at that time in consideration of a further consecutive closure order being made.
- 2.5 Sibelco UK, formerly WBB Minerals, wish to make such a further order for an extra period of five years from the date of the order's confirmation (14th January 2005) or until the sand extraction is completed (whichever were to be the sooner).
- 2.6 Mr C J Day of Southfield, Redbourne, North Lincolnshire, DN21 4QR, the owner of the land in question, is agreeable to the application and for the footpath diversion and stopping up.
- 2.7 A restoration programme was agreed with the sand-extraction company prior to extraction commencing. This is to be implemented by the company on the cessation of works, and to a condition not substantially less convenient to the public.
- 2.8 As approached from the north, the section of Public Footpath 210 to be diverted runs from point A on the map in a first southerly direction then east-south-easterly from a point on the existing public footpath, some 660 metres south of Brigg Road and 683 metres west of Public Bridleway 241, to its junction with the existing public bridleway within the farmyard of Manor Farm at point B.
- 2.9 As approached from the west, the section of Public Footpath 210A to be stopped up runs from point C on the map in an east-south-easterly direction from a point on the existing Public Footpath 210, some 920 metres south of Brigg Road and 730 metres west of public bridleway 241, to its junction with the existing public bridleway, some 328 metres north of Manor Farm at point D. Appendix One shows the 730-metre-long public footpath that would replace it.
- 2.10 Appendix Two shows the location of the public rights of way within the Parish of Manton.
- 2.11 The application for the extension period of five years was made on 21 May 2009, under the original planning application 1999/169, by Sibelco UK, Brookside Hall, Congleton Road, Arclid, Sandbach, Cheshire, CW11 4TF.
- 2.12 The PROW General Appendix outlines the legal background in more detail.
- 2.13 Because the diversion and stopping up are both temporary, the definitive map and statement will not have to be modified in consequence.

3. OPTIONS FOR CONSIDERATION

- 3.1 Extend the temporarily diversion and stopping up orders [for a further five years or until mineral extraction ceases, whichever is the sooner] as requested.
- 3.2 Decline to extend the temporarily diversion and stopping up orders.

4. ANALYSIS OF OPTIONS

- 4.1 The route of the temporary diversion would follow the inside of the northern perimeter of the site in an east-south-easterly direction for 730 metres.
- 4.2 The width of the proposed footpath would be 1.5 metres for the comfort and convenience of members of the public using it and is suitable underfoot for use as a footpath.
- 4.3 To uphold Sibelco UK's application North Lincolnshire Council must be satisfied that the requirements of section 257 and 261 of the Town and Country Planning Act 1990 have been met, as referred to in paragraph 6.1 below.
- 4.4 Officers believe that the proposed temporary diversion of a section of Public Footpath 210 and the proposed temporary stopping up of Public Footpath 210A are both necessary if sand extraction is to be continued.
- 4.5 Effectively the original temporary stopping-up order required that the footpaths be restored after five years at the latest. The mineral company have therefore undertaken to restore the footpaths. If approval to make further diversion and stopping-up orders is given, extraction will recommence thereafter.

5. RESOURCE IMPLICATIONS (FINANCIAL, STAFFING, PROPERTY, IT)

5.1 Financial

- 5.1.1 The full cost incurred in the making of the order and the cost of advertising the making, confirming and certifying of the order under the Town and Country Planning Act 1990 to be met by the applicant, Sibelco UK. It is North Lincolnshire Council policy to charge applicants in full, as the law permits ("Local Authorities (Recovery of Costs for Public Path Orders) Regulations 1993").

6 OTHER IMPLICATIONS (STATUTORY, ENVIRONMENTAL, DIVERSITY, SECTION 17-CRIME AND DISORDER, RISK AND OTHER)

6.1 Statutory

1 Statutory

6.1.1 Under section 257 of the Town and Country Planning Act 1990, a local planning authority may by order authorise the stopping up or diversion of any footpath or bridleway if they are satisfied that it is necessary, not simply desirable, to do so in order to enable development granted under Part Three of the Act to be carried out.

6.1.2 Under section 261 of the Town and Country Planning Act 1990, where a local planning authority are satisfied, a) that an order made by them under section 257 is required for the purposes of enabling minerals to be worked by surface working and b) that the footpath or bridleway can be restored after the minerals have been worked, to a condition not substantially less convenient to the public, the order may provide for the stopping up or diversion of the footpath or bridleway during such period as may be prescribed by or under the order, and for its restoration at the expiration of that period.

6.1.3 The order may contain provisions for the stopping up at the expiry of the period of any highway which has been diverted and for the reconstruction and maintenance of the original highway.

6.1.4 If North Lincolnshire Council are satisfied that they should provide for the creation of an alternative highway for use as a temporary replacement for one affected by mineral extraction, they may do so.

6.1.5 "Minerals" includes all minerals and substances in or under land of a kind ordinarily worked for removal by underground or surface working. (Town and Country Planning Act 1990, section 336(1)).

6.1.6 The diversion and stopping up must be necessary to enable mineral extractions to be carried out.

6.2 Environmental

6.2.1 The temporary replacement footpath is attractive and equally as commodious to walkers. Furthermore, the new hedgerows and woodland strips and corridors to be planted following the completion of sand extraction should enhance the aesthetics of

the landscape through which Public Footpaths 210 and 210A run.

6.3 Risk

6.3.1 Any order made to divert a public footpath, even if only temporary, can be objected to. North Lincolnshire Council cannot confirm an order to which there remains an outstanding objection or representation correctly served during the four-week objection period. We can either formally resolve not to pursue an objected order to confirmation or send it to the Secretary of State for Environment, Food and Rural Affairs for confirmation.

6.3.2 If a statutory undertaker objects because the order creates a public right of way over land covered by works used for the purpose of their undertaking, or if the objection is not withdrawn, the order becomes subject to special parliamentary procedure.

6.3.3 Orders referred to the Secretary of State will be dealt with by written representations, hearing or inquiry. The order-making authority must normally meet their own costs, but in the case of inquiries can claim costs against a third party thought to have been acting unreasonably.

7. **OUTCOMES OF CONSULTATION**

7.1 Full consultation has taken place with all user groups, statutory undertakers, Manton Parish Council and Messingham Parish Council. (Please see Appendix Three.) None has indicated an intention to object should an order be made.

8. **RECOMMENDATIONS**

8.1 It is recommended that members:

8.1.1 approve the making of an order to extend the temporary diversion of part of Public Footpath 210, Manton; and

8.1.2 approve the making of an order to extend the temporary stopping up of Public Footpath 210A, Manton. An alternative


footpath along the northern perimeter of the site would be retained throughout the stopping-up period.

- 8.2 Both orders would be made under sections 257 and 261 of the Town and Country Planning Act 1990. Their duration would be five years or until mineral extraction over the land crossed by the footpaths ceased, whichever were the sooner.
- 8.3 The order would commence on the 14th January 2010, this being the date of expiry of the existing orders diverting and stopping up FPs 210 and 210A respectively.
- 8.4 The making of the new temporary orders would be contingent on the footpaths currently closed first being restored and briefly reopened.
- 8.5 It is recommended further that members:
 - 8.5.1 allow the Service Director Highways and Planning to confirm the order if it is unopposed; and
 - 8.5.2 agree to receive a further report should the diversion order be duly opposed.


