1. OBJECT AND KEY POINTS IN THIS REPORT

1.1 To fix the level of fees and charges for the financial year 2014/2015 in relation to the council's Asset Management, Culture and Housing Cabinet Portfolio.

1.2 The fees were last considered in March 2013.

3.2 Option 2 – to approve fees and charges set differently to appendix 1. The Cabinet Member has the options of agreeing the fees and charges proposed, or rejecting them.

4.1 Option 1 – This option takes into account the councils increases in income expectations as recently approved in the council's overall budget for 2014/15.

4.2 Option 2 – Approving fees & charges different to those set out at Appendix 1 may influence the ability to meet budgeted income levels.
