# COMMUNITY GRANT FUND APPLICATION BARTON PARTNERS IN PLAY

### 1. OBJECT AND KEY POINTS IN THIS REPORT

- 1.1 We have received a late application for community grant aid from Barton Partners in Play. This needs considering against the scheme criteria and available funds.
- 1.2 An urgent decision is required to allow for implementation in time for the school summer holidays which commence on Wednesday 26 July 2017.

#### 2. BACKGROUND INFORMATION

- 2.1 We have received a late grant aid application from Barton Partners in Play. They are seeking funding to deliver a summer playscheme during the school holidays for young people.
- 2.2 Support for Barton Partners in Play will mean that young people living in the Barton area will have access to affordable activities during the summer.

#### 3. OPTIONS FOR CONSIDERATION

- 3.1 The options available to the Cabinet Member are as follows.
  - approve the application
  - refuse support
  - offer support at a reduced level.

#### 4. ANALYSIS OF OPTIONS

- 4.1 The application meets the criteria for grant funding up to the level requested.
- 4.2 Rejecting the application or offering grant support at a reduced level could mean that Barton Partners in Play are unable to provide a playsheme this year.

### 5. **RESOURCE IMPLICATIONS (FINANCIAL, STAFFING, PROPERTY, IT)**

- 5.1 Financial
  - 5.1.1 The council has approved a revenue budget of £148,000 for 2017/18. To date, a total of £49,078 has been committed. This leaves £98,922 to allocate. The total amount required to support the application is £3,000.
- 5.2 Staffing, Property and IT
  - 5.2.1 There are no staffing, property or IT related implications to consider.
