- 2.1 On 12 December 2016 it was agreed that the Detailed Assessment Report presented to the Cabinet Member should be submitted to DEFRA.
- 2.2 DEFRA have approved the report recommendations. The report concluded
  - i) Low Santon AQMA should be revoked
  - ii) Scunthorpe Town AQMA should be reduced in size.
- 2.3 Consultation on air quality reports is a requirement of The Environment Act 1995.
- 2.4 DEFRA guidance states that local authorities should also consult for proposed AQMA changes.

#### 3. **OPTIONS FOR CONSIDERATION**

- 3.1 To consult on the revised report and the recommendations to change the two existing AQMA's.
- 3.2 To do nothing.

# 4. ANALYSIS OF OPTIONS

- 4.1 We must consult on our reports and AQMA proposals; this allows interested parties to add their comments and raises the profile of our work.
- 4.2 The council could be criticised for not meeting a statutory obligation.

# 5. **RESOURCE IMPLICATIONS (FINANCIAL, STAFFING, PROPERTY, IT)**

5.1 The council continues to be proactive on all air quality work within existing resources. The council has seen a big increase in the air quality work that it must carry out in the last few years. The council must prepare an air quality report every year and must declare an AQMA if air quality is poor. We must produce an Action Plan to improve air quality if an AQMA is declared.
