LICENSING FEES

1. OBJECT AND KEY POINTS IN THIS REPORT

- 1.1 On 21 November 2019, members of the Licensing Committee considered a report to review this process and review the proposed fee's which was approved.
- 1.2 Due to errors found in the end calculations the report is being resubmitted for member's consideration.
- 1.3 Members are asked to review the licensing fees in light of the current legislation and Case Law and consider the revised fees attached at Appendix A, to approve the revised fee structure.

2. BACKGROUND INFORMATION

- 2.1 The Licensing function is a statutory service delivered in accordance with various Acts of parliament. These activities cover a broad range, but can be grouped as follows
 - Alcohol and Entertainment
 - Gambling
 - Taxi and Transport
 - Street Trading, Highways Activities and Charitable Collections
 - Animal Welfare
 - General Licences and Registrations, including, Sex Establishments and Other Registrations and Authorisations
- 2.2 Following the court ruling in favour of *Hemming (t/a Simply Pleasure Ltd) and others v Westminster City Council*, councils and other licence fee charging bodies across the UK are allowed to recoup regulatory and enforcement costs instead of just the administration costs of granting a licence.
- 2.3 The court determined that the distinction between two types of licensing scheme, known as type A and type B. The details are as follows.

Type A: Applications for licences are made on terms that the applicant must pay:

- (i) on making the application, the costs of the authorisation procedures and formalities, and
- (ii) on the application being successful, a further fee to cover the costs of the running and enforcement of the licensing scheme.

Type B: Applications for licences are made on terms that the applicant must pay:

- (i) on making the application, the costs of the authorisation procedures and formalities,
- (ii) at the same time, but on the basis that it is refundable if the application is unsuccessful, a further fee to cover the costs of the running and enforcement of the licensing scheme.”

- 2.4 The fees for licensable activities can be set in a number of ways. They can be determined by parliament, thus a statutory fee, be a maximum fee or the fee can be set at the discretion of the Council. In some cases, no fee can be charged, for example, charitable collections.
- 2.5 Where the Council has discretion in setting the fees, we are bound by legislation and case law.
- 2.6 Looking at the fees and budgets for the licensing function, there are distinct elements the council needs to comply with, namely:
 - 2.6.1 The council cannot budget to make a profit or surplus from the licensing function.
 - 2.6.2 Income from one type of licence should not be used to subsidise another type of licence, save for applications relating to the same area, i.e. applications within Taxi Licensing can support other areas within Taxi Licensing.
 - 2.6.3 The Council may set fees to attain full cost recovery. The Council's policy is to attain full cost recovery, where possible.
- 2.7 In accordance with the legislation, the Provisions of Service Regulation 2009 and the relevant case law, the cost of administering and processing each application has been considered. Where an element can be included for enforcement it has been listed separately. The costs are based on the time each application takes to process and the costs of the licensing function. The revised fees following the review are attached as Appendix A. The review of the fees will allow the fees and charges to be robustly defended against any legal challenge.

- 2.8 If the council does not comply with the legislation and regulations, then it would be open to a legal challenge, which would have serious implications both financially and for the Councils reputation.
- 2.9 Applicants can apply for their licence and pay either one of the following ways.
- a) Pay application and processing fee only (Application Fee)
 - b) Pay application, processing and enforcement fee (Licence Fee)
- 2.10 Where the applicant has been unsuccessful in their application and have paid point b), they will be refunded the enforcement element of the payment. The Application Fee is non-refundable.
- 2.11 On 21 November 2019, members of the Licensing Committee considered a report to review this process and amended fee's which was approved. Due to errors found in the end calculations the report is being resubmitted for member's consideration, the errors highlighted in red.

3. OPTIONS FOR CONSIDERATION

- 3.1 Option 1 – To do nothing. Maintain the fees as they are now and accept the risk that the Council could be challenged.
- 3.2 Option 2 – To submit the proposed fee with an alternative fee.
- 3.3 Option 3 – To adopt the proposed fees

4. ANALYSIS OF OPTIONS

- 4.1 Option 1 – To do nothing would not address the issues arising from the report and would leave the Council open to legal challenge. This option would also mean that the fees and charges may be above the cost of processing the application and budgets are not addressed, thus meaning that there would still be an unrealistic expectation from income. In addition, there are certain types of application that we would not have a charge for at all.
- 4.2 Option 2 – In adopting this option; we could not charge more than the proposed fee as it would be unlawful and leave the Council open to challenge. If it is determined to charge less then, the service would not cover the cost of dealing with applications.
- 4.3 Option 3 – This option takes into account the current legislation and case law. Any change in the licence fee must demonstrate that we are not charging more than it cost to process the application and we cannot budget to make a profit.

5. FINANCIAL AND OTHER RESOURCE IMPLICATIONS (e.g. LEGAL, HR, PROPERTY, IT, COMMUNICATIONS etc.)

5.1 The net financial effect of implementing the proposed schedule of fees and charges will be a slight increase in income. The proposed fee includes an element to pay for additional resources within the licensing team.

6. OTHER RELEVANT IMPLICATIONS (e.g. CRIME AND DISORDER, EQUALITIES, COUNCIL PLAN, ENVIRONMENTAL, RISK etc.)

6.1 Reviewing the fees would ensure that the Council is compliant with the Provisions of Service Regulations 2009 and case law.

7. OUTCOMES OF INTEGRATED IMPACT ASSESSMENT (IF APPLICABLE)

7.1 Legal Services have advised that the Licensing service cannot make a profit, and that the cost recovery as outlined is not prohibited.

8. OUTCOMES OF CONSULTATION AND CONFLICTS OF INTERESTS DECLARED

8.1 Following approval, the fees will be advertised in accordance with any legal requirements. Any representations on the revised fees will be referred to the Chairman of the Committee for determination.

9. RECOMMENDATIONS

9.1 That fees & charges as detailed in Appendix A are approved subject to any advertising required.
